### 1. SCOPE AND APPLICATION:

Fox Cable Networks Services, LLC ("FCNS" or "we") wants you to be familiar with how we collect, use, and disclose information from and about you. This Privacy Policy describes our practices in connection with information collected through the FCNS websites on which it is posted (the "FCNS Sites"), and other content and services that link to or are otherwise subject to this Privacy Policy (collectively, the "FCNS Services"). Information about our affiliated companies ("FCNS Affiliates") is available at <a href="https://www.foxcorporation.com">https://www.foxcorporation.com</a>.

Certain state privacy laws require particular disclosures in privacy policies. <u>California residents, please</u> see the California Consumer Privacy Act Notice in Section 8 below. <u>Consumers in Virginia, Colorado,</u>

<u>Connecticut and other states with similar privacy laws, please see Section 9 below.</u> By using the FCNS Services, you agree to the terms and conditions of this Privacy Policy.

As set forth in our Terms of Use, available at <a href="https://allbtngames.com/TermsOfUse.pdf">https://allbtngames.com/TermsOfUse.pdf</a>, the FCNS Services are for a general audience, are not targeted to children, and do not knowingly collect personal information from children under 13 years of age.

This Privacy Policy applies to all users, including both those who use the FCNS Services without being registered with an FCNS Service and those who have registered with one or more FCNS Services.

This Privacy Policy applies to FCNS's collection, use, and disclosure of your personal information (i.e., information that identifies a specific person, such as full name or email address). It also describes generally FCNS's practices for handling non-personal information (for example, interests, demographics, and services usage). Please note that the information that we may collect, use, and/or disclose varies based upon a user's interactions with the FCNS Services.

### 2. COLLECTION OF INFORMATION:

Depending on your interactions with us, FCNS and our service providers may collect the following information from and about you:

**Registration Information** is information you submit to register for our FCNS Services, for example to create an FCNS account, receive a newsletter, or enter a contest or sweepstakes. Registration Information may also include, for example, name, email address, zip code, and phone number.

**Activity Information**. When you access and interact with the FCNS Services, FCNS and its service providers may collect certain information about those visits. For example, in order to permit your connection to the FCNS Services, our servers receive and record information about your computer, device, and browser, including potentially your IP address, browser type, and other software or hardware information. If you access the FCNS Services from a mobile or other device, we may collect a unique device identifier assigned to that device, or other transactional information for that device. In certain circumstances, we also may collect geolocation data (including your precise or general location).

Cookies and other tracking technologies (such as browser cookies, pixels, beacons, local storage, and other mechanisms) use various approaches to collect and store data. Some of these technologies store data in the browser or on your device. Other technologies may use network-related or other information to recognize your device (e.g., IP address). FCNS's websites and other services may use these technologies, for example, when you first request a web page and to store data on your computer or other device so the website or other service can access information when you make subsequent requests for pages from that service. Depending on your interactions with us, these technologies may also be used to collect and store information about your usage of the FCNS Services, such as pages you have visited, search history, and other content you have viewed.

Other parties that support the FCNS Services, for example, by providing analytics or other services, may also use these technologies to collect similar information when you use the FCNS Services or other parties' services. Those other parties may also use these technologies, along with activity information they collect, to recognize you across the devices you use, such as a mobile device and a laptop or other

computer. In some circumstances, their use is governed by the privacy policies of the parties using such technologies.

Your browser may be initially set to accept cookies, but you can change your settings to notify you when a cookie is being set or updated, and to block cookies altogether. Please consult the "Help" section of your browser for more information, including on how to clear data from local storage and, depending on your browser, how to turn off other data collection by the browser. Please note that by blocking any or all cookies, you may not have access to certain features, content or personalization available through the FCNS Services.

**Information from Other Sources**. We may supplement the information we collect with information from other sources, such as publicly available information about your online and offline activity from social media services, commercially available sources, and information from our FCNS Affiliates or business partners.

Depending on your interactions with us, FCNS may not have collected information from you for each of the categories above.

**'Do Not Track'**. At this time we do not respond to the 'Do Not Track' signal, as we await the work of interested stakeholders and others to develop standards for how the 'Do Not Track' signal should be interpreted.

# 3. USE AND DISCLOSURE

We may use and disclose some or all of the information we collect from and about you for the purposes listed below. Please note that these uses and disclosures may vary based on your interactions with us.

**To provide the FCNS Services.** We use information we collect from and about you to provide the FCNS Services. This may include:

- to measure, maintain and improve those FCNS Services and features and to develop new products and services, including conducting research and quality and safety assurance measures;
- to improve your experience with both online and offline FCNS Services by delivering content you will find more relevant and interesting, including marketing messages;
- to perform identity verification;
- to allow you to participate in online games, contests, other promotions, or rewards programs;
- to provide you with customer support and to respond to inquiries;
- to make inferences and predictions about your potential areas of interest in order to provide you with content that is more interesting, personalized, and relevant to you;
- to maintain our facilities and infrastructure;
- to comply with internal policies, including accounting, audit, and other internal functions; and
- to maintain records, conduct risk and security controls, and monitoring.

To allow service providers to assist us in providing and managing the FCNS Services. Information we collect from and about you may be made available to certain service providers, such as contractors, analytics and other measurement companies, and agents or sponsors, who help us analyze and understand your use of the FCNS Services and manage and/or provide the FCNS Services.

**To provide co-branded services and features**. We may offer co-branded services or features, such as contests, sweepstakes or other promotions together with other companies ("Co-Branded Services"). These Co-Branded Services may be hosted on FCNS Services or on that other party's service. By virtue of these relationships, we may share information you submit in connection with the Co-Branded Service with that party. That other party's use of your information will be governed by its privacy policy.

**To contact you**. FCNS may periodically send promotional materials (e.g., newsletters) or notifications related to the FCNS Services. If you want to stop receiving promotional materials, you can change your account setting, follow the unsubscribe instructions at the bottom of each email, or send an email to <a href="FCNS.Privacy@fox.com">FCNS.Privacy@fox.com</a>. There are certain service notifications and other non-promotional emails that you may not opt-out of, such as notifications of changes to the FCNS Services or policies

To share with our FCNS Affiliates. FCNS may share information we collect from and about you as described in this Privacy Policy with FCNS Affiliates for the purposes described in this Privacy Policy. A link to a website with information about FCNS Affiliates can be found at the beginning of this policy. Users who visit FCNS Affiliates' services should still refer to their separate privacy policies, which may differ in some respects from this Privacy Policy.

**To share with business partners**. FCNS may share information we collect from and about you as described in this Privacy Policy with business partners to permit them to send you marketing communications consistent with your choices.

To protect the rights of FCNS and others. There may be instances when FCNS may use or disclose information we collect from and about you as described in this Privacy Policy, including situations where FCNS has a good faith belief that such use or disclosure is necessary in order to: (i) protect, enforce, or defend the legal rights, privacy, safety, or property of FCNS, our FCNS Affiliates or our or their employees, agents and contractors (including enforcement of our agreements and our terms of use); (ii) protect the safety, privacy, and security of users of the FCNS Services or members of the public; (iii) protect against fraud or for risk management purposes; (iv) comply with the law or legal process; or (v) respond to requests from public and government authorities.

To complete a merger or sale of assets or other corporate transaction. If FCNS sells all or part of its business or makes a sale or transfer of its assets or is otherwise involved in an acquisition, reorganization, merger or transfer of all or a part of its business (including in connection with a bankruptcy or similar proceedings), or other corporate transaction, FCNS may transfer or disclose information we collect from and about you as described in this Privacy Policy to the party or parties involved in the transaction as part of that transaction.

Depending on your interactions with us, FCNS may not have collected, used or disclosed information from or about you in each of the categories above, and to the extent that FCNS has disclosed information from or about you, it may not include all of the information that we collect from and about you as described in this Privacy Policy.

Please note that when the information collected from or about you does not identify you as a specific person, we may use that information for any purpose or share it with other parties, to the extent permitted by applicable law.

### 4. SECURITY

FCNS uses commercially reasonable administrative, technical, personnel, and physical measures designed to safeguard information in its possession against loss, theft and unauthorized use, disclosure, or modification. However, no one can guarantee the complete safety of your information.

#### **5. USER ACCESS AND CONTROL**

We will try to comply with your request as soon as reasonably practicable and consistent with applicable law. Please note that, subject to applicable law, in some cases we may not comply with your request where we may require your information in order to comply with applicable law, or to protect, enforce, or defend our rights or employee rights, or those of a FCNS Affiliate.

If you are a resident of California, please see the section entitled "California Consumer Privacy Act Notice," below, for more information about the rights you have under California law. If you are a consumer in Virginia, Colorado, Connecticut, or other state with a similar privacy law, please see the section entitled "For Consumers in Virginia, Colorado, and Connecticut, and Other U.S. States with Similar Privacy Laws," below, for more information about your rights under Virginia, Colorado, Connecticut, and other similar state privacy laws.

# **6. OTHER IMPORTANT INFORMATION**

**Updates to Privacy Policy**. FCNS may modify this Privacy Policy. Please look at the Effective Date at the top of this Privacy Policy to see when this Privacy Policy was last revised. Any changes to this Privacy Policy will become effective when we post the revised Privacy Policy on the FCNS Services.

**Location of Data**. The FCNS Services are hosted in and managed from the United States. If you are a user located outside the United States, you understand and consent to having any personal information processed in the United States or in any other country in which we have facilities or in which we engage

service providers. The United States and other countries' data protection laws may not be the same as those in your jurisdiction. In certain circumstances, courts, law enforcement agencies, regulatory agencies, or security authorities in the United States may be entitled to access your personal information.

**Linked Services**. The FCNS Services may be linked to sites operated by unaffiliated companies, and may carry advertisements or offer content, functionality, games, newsletters, contests or sweepstakes, or applications developed and maintained by unaffiliated companies. FCNS is not responsible for the privacy practices of unaffiliated companies and once you leave the FCNS Services or click an advertisement, you should check the applicable privacy policy of the other service.

In addition, FCNS is not responsible for the privacy or data security practices of other organizations, such as Meta, Instagram, X (formerly Twitter), Apple, Google, Microsoft or any other app developer, app provider, social media platform provider, operating system provider, wireless service provider, or device manufacturer, including in connection with any information you disclose to other organizations through or in connection with the FCNS Services.

**Data Retention.** We will retain your information for the period necessary to fulfill the purposes outlined in this Privacy Policy unless a longer retention period is required or allowed by law.

Remember that even after you cancel your account, or if you ask us to delete your personal information, copies of some information from your account may remain viewable in some circumstances where, for example, you have shared information with social media or other services. Because of the nature of caching technology, your account may not be instantly inaccessible to others. We may also retain backup information related to your account on our servers for some time after cancellation or your request for deletion, for fraud detection or to comply with applicable law or our internal security or recordkeeping policies. It may not always be possible to completely remove or delete all of your information due to technical constraints, or contractual, financial or legal requirements.

**Deidentified Information**. To the extent we process "deidentified" personal information, as defined under applicable law, we will maintain and use that information in deidentified form and will not attempt to reidentify the information except as permitted by applicable law.

**Sources of Personal Information.** We collect Personal Information directly from California residents themselves, as well as from joint marketing, co-branding or co-promotional partners; FCNS Affiliates; and sources of demographic and other information. Depending on the individual's interactions with us, we may not have collected Personal Information from each (or any) of these categories of sources.

**Purposes.** We may use Personal Information and/or disclose it to third parties for the following purposes:

- to operate, manage, and maintain our business, including in connection with a sale, acquisition, reorganization, merger, transfer of all or a part of our business, or other corporate transaction (e.g., a bankruptcy or similar proceeding);
- to provide our products and services;
- to accomplish our business purposes and objectives, including:
  - o developing, improving, repairing, and maintaining our products and services;
  - o personalizing, our products and services;
  - o conducting research, analytics, and data analysis;
  - maintaining our facilities and infrastructure;
  - o quality and safety assurance measures;
  - conducting risk and security controls and monitoring;
  - detecting and preventing fraud;
  - performing identity verification;
  - o performing accounting, audit, and other internal functions;
  - o complying with law, legal process, and internal policies;
  - o maintaining records; and
  - exercising and defending legal claims.

Depending on the California resident's interactions with us, FCNS may not have used Personal Information collected about that resident for each of these purposes, and to the extent that FCNS has disclosed Personal Information about that resident, it may not include all of the Personal Information collected about that resident.

"Sale" and "Sharing" of Personal Information. We do not "sell" or "share" Personal Information as defined in the CCPA. Please note, however, that the CCPA definitions of "sale" and "sharing" does not include, for example, the transfer of Personal Information as an asset that is part of a merger, bankruptcy, or other similar transaction involving of all or any portion of our business.

**Sensitive Personal Information**. We do not process "sensitive" Personal Information for purposes other than those specified in the CCPA Regulations section 7027(m) (such as to provide the services and for security purposes).

- (1) **Right to Know.** You have the right to request that we disclose to you the following information:

  - The specific pieces of Personal Information we collected about you for the applicable time period;
  - The business or commercial purpose for collecting, disclosing, or selling Personal Information about you;

- The categories of Personal Information about you that we sold and the categories of third parties to whom we sold that Personal Information; and
- The categories of Personal Information about you that we otherwise shared or disclosed and the categories of third parties with whom we shared or disclosed that Personal Information.

Once verification is complete, we may communicate directly with you for privacy and security reasons.

Please note that, in some instances, we may decline to honor your request, where, for example, we are unable to verify your identity or an exception to this right applies.

(2) **Right to Request Deletion.** You have the right to request that we delete Personal Information we collected from you.

You can use an authorized agent to submit a request for deletion. When submitting a request online, your authorized agent should select the "Other" option on the form and, in the field provided, include your name, your email address, and whether or not you have an account/profile with us. In addition to verifying your identity, as described above, we also will need to verify your authorized agent's ability to act on your behalf (e.g., by receiving a copy of your signed permission). Once verification is complete, we may communicate directly with you for privacy and security reasons.

Please note that, in some instances, we may decline to honor your request where, for example, we are unable to verify your identity or an exception to this right applies.

(3) **Right to Request Correction**. You have the right to request that we correct inaccurate Personal Information we collected about you.
